Marlene Shiels is the chief executive of Capital Credit Union and represents the British credit union movement on the World Council of Credit Unions' (WOCCU) Board of Directors. A board member of the Chartered Institute of Bankers in Scotland, she is passionate about providing affordable, accessible financial solutions for people of all walks of life and particularly for those in financial difficulty.

Kareen Ryden is a registered trainee practitioner with the Institute of Transactional Analysis (ITA) and a member of the International Transactional Analysis Association. She has a background in law and business, having been a partner in a large law firm and director of a Scottish property consulting company.

She joins the board with a particular interest in the connection between debt and depression.
